#### **GETTING TO KNOW ST. FRANCIS**

### **DOG LICENSES**

All dogs must have a dog license issued by the St. Francis Police Department. The license is issued for as long as the rabies vaccine is valid. Must provide proof of rabies vaccination. A 1-2 year license has a cost of \$10 and a 3 year license has a cost of \$15.

# **BURNING PERMITS**

Burning permits are available to St. Francis residents for \$10.00. Permits can be purchased at St. Francis Fire Dept. Permits will only be issued to properties that have a well. Any fire larger than  $3' \times 3'$  requires a burning permit. Permits are valid for 3 days with burning hours from 6 PM - 8 AM. For questions, please call the Fire Department at 763-753-2334. ### **SNOWMOBILE PERMITS**

An annual permit must be purchased in order to ride a snowmobile in the local access areas of St. Francis. Snowmobile permits can be purchased for \$15 at the St. Francis Police Department. A color is assigned to the permit holder that is based on the address of the permit holder. The permit holder may take the most direct route from the primary residence to the state trail within the colored zone. Driving outside the colored zone or in the orange zone is not permitted. The local access sticker must be placed on the hood, visible from the left side. The year sticker must be placed directly below the local access sticker. Snowmobile Map

### **GOLF CART PERMITS**

An annual permit is required by the St. Francis Police Department in order to ride golf carts to and from the golf course. There is no cost to this permit. Golf carts are restricted to the area directly surrounding the golf course using 237th Ave NW as the northern boundary, 230th Ave NW as the southern boundary with the 2400 block as the eastern boundary and the 3000 block as the western boundary. Golf carts are to be operated for the sole purpose of traveling to and from the golf course and are permitted on the road from sunrise to sunset. The golf cart must display a slow moving vehicle emblem as provided for in Minnesota State Statute Section 169.522.

### **GUN PERMITS**

PERMIT TO PURCHASE: Permits are issued from St. Francis Police Department to residents of St. Francis. Applicants are required to pick up their approved permit from the St. Francis Police Department. Valid identification is required in order to pick up the permit card.

Applicants need to read the application carefully and ensure the entire application is filled out. It can take up to 7 business days to approve applications. Staff will call the applicant when the permit is ready to be picked up.

PERMIT TO CARRY: Applicants must bring their application to the county sheriff's office in which they reside. The permit to carry acts as a permit to purchase. Those who have a permit to carry do not need a permit to purchase.

## HOME IMPROVEMENTS

(BUILDING PERMITS)

Most home improvement projects requires building permits, including basement finishing, porches, decks, sheds, roofing, siding, and more. Structures that are constructed, moved, improved, demolished, or altered require a permit. Permits are required for smaller projects such as plumbing, heating and air conditioning as well. Electrical permits are obtained through the State—for all other permits contact the St. Francis Building Department at 763-753-2630.

Permit application forms and fees are available on the <u>city website</u> or can be obtained at City Hall.

#### **BUILDING PERMITS PROTECTYOUR INVESTMENT**

To some, obtaining a permit may seem to be an added cost, time delay, and unwarranted regulations. However, a building permit ensures that proper services and code are being met for your safety. Residents may sometimes overlook the benefits of obtaining a building permit and appropriate inspection. In addition to assuring yourself that your family and property are protected, you will also have peace of mind knowing that the work has been done properly and in accordance with all codes. Building without a permit may cause future maintenance problems or affect the resale of your home.

They protect approximately 7,000 citizens over an area of about 27 square miles. The City of St. Francis houses its own police department, school district, and an abundance of industry and retail services. We participate in an active mutual aide/auto aide program to ensure sufficient resources from and for our neighboring fire departments when needed.
