Animal Control change

Effective July 18, 2022, St. Francis began the animal control contract with On Line Retrievers. If you have a lost dog and believe it was picked up by animal control, On Line Retrievers will post impounded dogs on their Facebook page https://bit.ly/3OgZvO5.

Please share the page so we can help families reconnect with lost pets.



To speak with someone at On Line Retrievers regarding a possible impounded dog, they can also be reached by calling 320-492-5865.

If you have lost a dog and believe it may have been impounded prior to this change, contact The Canine Country Club at 651-373-0566.

St. Francis also requires dogs to be licensed within the city (Ordinance 8-3-1 C). You can stop at St. Francis Police Department with proof of your dog's rabies vaccination and purchase a license. The cost depends on how long you buy a dog license for, anywhere from one to three years and \$5 to \$15, respectively. Purchasing a license also allows us to have contact information if your dog is found wandering around and picked up by officers.

Message from your Mayor

On Line Retrievers has been providing animal control services for the past 12 years and serves several communities, including Mille Lacs County, Isanti County, and townships in Sherburne County. They operate a facility located in Ogilvie, Minn., approximately 31 miles north of St. Francis. They are currently licensed by the Minnesota Board of Animal Health and hold a commercial general liability insurance certificate.

I want to let everyone know about the new City online bill payment service. On the city website, at the bottom of the page, you will see a tab labeled "Online Bill Pay" click on it to set up your account to pay online. It's new and improved.

Watershed Management Organization has a vacancy available in St. Francis

The Upper Rum River Watershed Management Organization (URRWMO) has one vacancy for the City of St. Francis. If you want to join, contact City Clerk Jenni Wida at 763-235-2303 or jwida@stfrancismn.org.

The URRWMO is a joint powers organization, including the Cities of St. Francis, Oak Grove, Nowthen, Bethel, and portions of East Bethel. A small corner of Ham Lake also falls within the URRWMO. The WMO Board is made up of representatives from each of these cities.

This organization seeks to maintain the quality of area lakes, rivers, streams, groundwater, and other water resources across municipal boundaries. Resources of particular importance to the URRWMO include the Rum River, Seelye Brook, Ford Brook, Cedar Creek, and numerous ditches that drain into the Rum River. This stretch of the Rum River is designated a state Scenic and Recreational Waterway. Lake George and East Twin Lakes, the primary recreation lakes in the watershed, are also of high priority, in addition to many smaller lakes and wetlands.

The work of the URRWMO is guided by its 10-year Watershed Management Plan. That work includes water quality and hydrology monitoring, public outreach, and water quality improvement projects. The member cities complete several important tasks, including permitting and stormwater system maintenance.


Are you interested in helping to guide the growth of the City? Join the Planning Commission!

PREVENTION WEEK October 9-15

As Fire Prevention Week approaches (October 9-15), the St. Francis Fire Department reminds residents that "Fire won't wait. Plan your escape."

The St. Francis Fire Department wants to share these key home fire escape planning tips:

- Make sure your plan meets the needs of all your family members, including those with sensory or physical disabilities.
- Smoke alarms should be installed inside every sleeping room, outside each separate sleeping area, and on every level of your home. Smoke alarms should be interconnected so that when one sounds, they all sound.
- Know at least two ways out of every room, if possible. Make sure all doors and windows open easily.
- Have an outside meeting place a safe distance from your home where everyone should meet.
- Practice your home fire drill at least twice a year with everyone in the household, including guests. Practice at least once during the day and at night.

Message from St. Francis Public Works

When a blanket of fresh snow is on the ground, it can be difficult for snowplow operators to see the curbs or the edge of the road. Putting a wooden lathe next to the curb can help the snowplow operators locate the border during the first or second snowfall. A lathe is used as a guide for the snowplow operator, not as a protector along your property. When putting in stakes at your property, do NOT use metal posts. The stakes need to be of a breakaway design so as not to cause injury to others. City Hall, 23340 Cree Street NW, and Public Works, 4058 St Francis Boulevard NW, have wooden lathes available for pickup during regular business hours.

Time to check your water _____softener settings! From the Street to the Streams

Blowing leaves from your yard to the street, which is also called illicit discharge, causes plugged storm drains and can potentially cause a water backup when it rains. Although leaves seem natural and harmless, excess leaves also threaten the health of our waters. Leaves in the gutter of the street in front of your house are on the fast track to our lakes and rivers. When it rains, leaves are washed into storm drains and directly into the nearest body of water. Once they are in the water, they begin to decay, then release nutrients that contribute to the green stuff or algae you see on the water's surface. An excess of algae can make recreation unpleasant. Also, excess algae will use up the oxygen in the water, which in turn suffocates fish and other aquatic species in the water.

Some watershed-friendly alternatives to blowing leaves into the street:

- Compost leaves for a nutrientrich fertilizer for your gardens.
- Mulch leaves with a mower and leave directly on the yard.
- Use chopped-up leaves as winter mulch for your plants or gardens.
- Drop off leaves at the Anoka County Compost, call for hours and prices at 763-767-7964; their address is 13285 Hanson Boulevard NW, Coon Rapids, MN 55448.

The distance between your yard and the water's edge is as close as the nearest storm drain. Keeping leaves out of the street is important to protecting our waters.

Minnesota Statewide Chloride Management Plan

Reducing chloride at the source is needed throughout the state of Minnesota, not only to restore already impacted waters but also to protect all water resources. Chloride is persistent in the environment and is difficult to remove once it is there. This also means that chloride will accumulate in the environment over time. There are multiple sources to consider, various options to reduce chloride, and a large geographical area to address. The primary purpose of this plan is to provide guidance, resources, and information to individuals and organizations, assisting with the critical decisions of what, how, and when to manage chloride.

The Minnesota Pollution Control Agency (MPCA) has partnered with local partners, other state agencies, and experts across the state to create a plan for effectively managing salt use to protect our water resources in a responsible and strategic approach. Solutions were developed collaboratively to find a balance between clean water and salt use. The Statewide Chloride Management Plan (CMP) incorporates water quality conditions, sources of chloride, salt reduction strategies, protection strategies, water quality monitoring recommendations, and measurement and tracking of results.

This plan aims to provide information and strategies to assist local partners in reducing salt at the source while providing safe and desirable conditions for the public. There are several sources of chloride impacting the state's water resources, including salt applied to roads, parking lots, and sidewalks for winter maintenance, water softener brine discharges to municipal wastewater treatment plants (WWTP) and septic systems, industrial discharges, agricultural fertilizers, land application of manure, WWTP sludge, and dust suppressants.

A key challenge in reducing salt usage is balancing the need for public safety with the growing expectation for clear, dry roads, parking lots, trails, and sidewalks throughout the mix, severity, and duration of winter conditions. Notable efforts have already been made by the Minnesota Department of Transportation (MnDOT) and many cities, counties, and others to improve winter maintenance while reducing salt usage.

Another key challenge is educating the public on proper water softening practices. There is no requirement to soften your water; it is a personal decision that can affect your home and the environment. Certain commercial or residential appliances require or operate more



effectively with softened water; however, the specific degree of softening can often be calibrated to individual preferences. Additionally, some municipalities offer centralized hardness reduction at the drinking water facility prior to distribution, supporting higher efficient residential and commercial softening processes and reducing salt use. Older residential softening units may be less efficient than newer models, and these factors often lead to more chloride usage than is necessary to meet specific needs and tastes.

registering for voting and where to vote in the General Election on Tuesday, November 8:

You may register and vote in Minnesota if you:

- Will be at least 18 years old on election day.
- Are a citizen of the United States.
- Will have resided in Minnesota for 20 days immediately preceding election day.
- Maintain residence at the address given on the registration form.
- Are not under court-ordered guardianship in which the court order revokes my right to vote.
- Have not been found by a court to be legally incompetent to vote.
- Have been convicted of a felony, but pledge, the felony sentence has expired (been completed) or have been discharged from the sentence, and have read and understand this statement, that giving false information is a felony punishable by not more than five years imprisonment or a fine of not more than \$10,000, or both.

Voting in the General Election will be at the following sites. The polls are open from 7:00 a.m. until 8:00 p.m.

there are over 200 million firearms in the United States? Studies suggest they are kept in approximately half of all households. This makes it likely that children will encounter a firearm at some point, so ensure they are informed.
