Responsibilities of property owners: by signing the permit below, you are agreeing to understanding and reading the Chicken Permit codes. City Code addresses the following:

- Properties less than 2.5 acres = no more than five (5) chickens
- Properties 2.5 to 5.0 acres = no more than ten (10) chickens
- 20 permits citywide will be allowed for properties less than 2.5 acres
- No roosters, no on-site butchering, no cockfighting, no infested coops or feed bins.
- Chickens must always be confined to a pen or run, and cannot be in the principal dwelling, garage, front yard or side yard.
- Permit holders cannot treat chickens in a cruel or inhumane manner
- Dead chickens must be disposed of according to the Minnesota Board of Animal Health rules which require chicken carcasses to be disposed of as soon as possible after death, usually within 48 to 72 hours.

REQUIRED MATERIALS – The following materials must be submitted in order to be considered a complete application.

- □ Chicken Permit completed and signed.
- □ Permit Fee of \$120, to be paid, once application is approved
- □ Scaled drawing (site plan) showing location, size, dimension of the coop & run. The site plan shall include:
  - 1. the proposed distances between the coop & run from neighboring homes
  - 2. proposed distances from other structures on the subject property,
  - 3. the property lines and the distances from them
- □ The maximum number of chickens to be kept on site
- □ A detailed waste removal plan addressing feces/manure and dead birds
- □ IF APPLICABLE Signed authorization from property owner or Home Owner Association
- □ IF APPLICABLE Electrical Permits shall be submitted to the State of Minnesota.

## COOP AND RUN REQUIMENTS

- Chickens must have BOTH a coop and run. A coop is the structure for the keeping & housing of chickens, and a run is a fully enclosed and covered area attached to a coop where chicken can roam unsupervised.
- Coops do not count towards a properties maximum accessory structure count
- All fencing, construction, electrical work, etc., must adhere to all applicable building and zoning codes, and all permits & licenses must be obtained.
- Chicken coops and runs must be at least 15 feet from side lot lines, and must be closer to the principal dwelling on the permitted property than to any dwelling on an adjacent property.
- Coops and runs must be 25 feet from wetlands, ponds, filtration/infiltration basins.
- Coops shall have a maximum footprint area of ten (10) square feet per chicken and a minimum footprint of five (5) square feet per chicken
- Runs shall have a maximum footprint area of twenty square feet per chicken, and a minimum footprint

	area of ten (10) square feet per chicken.										
•	The coop shall be elevated a minimum of twelve (12) inches off the ground and may not exceed a										
	height of six (6) feet as measured from the ground.										
•	Coops must be winterized if chickens are to be kept between November 1 <sup>st</sup> and April 30 <sup>th</sup> of any given										
	year.										
•	Once an owner stops raising chickens the coop and run must be removed within 10 days.
